- Ensuring that the Union is working towards its strategy and pushing the leadership team to carry out objectives within it.
- Ensuring that it is legal, solvent, well-run, and delivering its charitable objectives.

- Ensuring that the charity adheres to charity law and other relevant legislation.
- Always acting in the Students' Union's best interests and abiding by the Students' Union code of conduct.
- Maintaining the Union's governing document and the principles defined in The Charity Governance Code charitygovernancecode.org/en
- Attending Board meetings.

Financial Responsibilities of Trustees

- Ensuring that the Union is in a good financial position and is sustainable.
- Ensuring that the Union uses its resource to benefit UCLan students.
